**THE UMCS SUPPORTIVE HOUSING PROGRAM PROVIDES LOW-INCOME AND AFFORDABLE HOUSING OPTIONS ACCOMPANIED BY ON-SITE SOCIAL WORK SERVICES AND OTHE PROGRAMMING DESIGNED TO ASSIST CHILDREN AND FAMILIES TO MEET THEIR NEEDS AND MAINTAIN HOUSING. THE PROGRAM PROVIDES HOUSING AND SERVICES TARGETING FAMILIES WHICH HAVE A HEAD OF HOUSEHOLD WITH A BEHAVIORAL HEALTH DIAGNOSIS, AS WELL AS FAMILIES WITHOUT SUCH A DIAGNOSIS.
